1 INTRODUCTION AND SUMMARY

This is a Final Rate Order of the Ontario Energy Board (OEB) on an application filed by Oshawa PUC Networks Inc. (Oshawa PUC) to change its electricity distribution rates as of January 1, 2018 and January 1, 2019.

On December 20, 2017, the OEB issued a Decision and Order (Decision) outlining the final parameters that Oshawa PUC should use to calculate its rates to be effective January 1, 2018 and January 1, 2019. Oshawa PUC filed a draft rate order implementing the OEB's Decision. The draft rate order included detailed supporting information showing the calculation of final rates.

OEB staff commented that there seemed to be inconsistencies with the Decision and the draft rate order regarding capital expenditures and also minor calculation errors for working capital allowance, retails transmission service rates, and deferral and variance accounts. In Oshawa PUC's reply comments, it either provided clarification or agreed with OEB staff and provided an updated draft rate order addressing OEB staff's comments.

The OEB has reviewed Oshawa PUC's revised draft rate order and proposed Tariff of Rates and Charges, and is satisfied that they accurately reflect the Decision.

As a result of the OEB's Decision in this proceeding and this Rate Order, it is estimated that the total monthly bill, before taxes, for a typical residential customer with an average monthly consumption of 750kWh will decrease by 0.04% or \$0.04 on January 1, 2018 and increase by 2.25% or \$2.31 on January 1, 2019.

2 THE PROCESS

On December 20, 2017, the OEB issued its Decision outlining the final parameters that Oshawa PUC should use to calculate its rates to be effective January 1, 2018 and January 1, 2019. Oshawa PUC filed a draft rate order on January 8, 2018. OEB staff filed comments on the draft rate order. Oshawa PUC responded to comments and filed a revised draft rate order on January 22, 2018.

3 RATE ORDER

The OEB has reviewed the information provided in support of Oshawa PUC's revised draft rate order and proposed Tariff of Rates and Charges. The OEB has made a few formatting changes to the Tariff of Rates and Charges to ensure consistency with the tariff sheets of other electricity distributors. The OEB finds that the Tariff of Rates and Charges in Schedule A accurately reflects the Decision and is consistent with the OEB's format.

This Rate Order establishes Oshawa PUC's distribution rates effective January 1, 2018 and January 1, 2019.

4 IMPLEMENTATION

The new rates are to be effective and implemented on January 1, 2018 and January 1, 2019.

5 ORDER

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. The Tariff of Rates and Charges set out in Schedule A of this Rate Order is final effective January 1, 2018 and January 1, 2019. The Tariff of Rates and Charges will apply to electricity consumed or estimated to have been consumed on and after January 1, 2018 and January 1, 2019. Oshawa PUC shall notify its customers of the rate changes no later than the delivery of the first bill reflecting the new rates.
